

## **Stags Table & Tent Hire, equipment types and our terms & conditions (2024-25)**

We provide 6 foot by 2.5 foot wooden rectangular table or white folding rectangular tables.

- ✓ 1-3 days hire £7 per table
- ✓ 1 week £12 per table

Tables are intended to be used with your own tablecloths

Ideal for events, festivals, shows or for laying food or creating a bar area. Can also be used to create a long table. Each Table will seat 6 people along the side and 2 at the ends. All tables have folding legs which are locked into place when pulled out.

### **3x3 Commercial gazebo tents:**

Gazebo 3m x 3m (10ft x 10ft). This sized Gazebo provides excellent cover for all types of events. These are supplied with walls and canopy. The aluminium leg poles and frame are 50mm in diameter and 2mm in depth: the hexagonal framework provides exceptional strength, and benefits from all profile aluminium and steel joints. The covering/canopy is made of 500 Denier polyester PVC. The walls simply velcro to the roof and consist of one door that opens 2.5 metres and this can be positioned any side you want. A window wall with a cover so you can roll up the cover and have a viewing window or just leave it down as a blank wall. The other two walls are plain walls. All the walls zip together giving you complete 360 degrees cover.

We recommend that we pitch this Gazebo on grass, decking, patio or a hard surface. If the Gazebo cannot be staked down we can add [weights](#) at an additional cost.

If you need a bigger area we can join the gazebos together with gutters and infills (additional fees will be applied).

### **Explorer tent:**

Filled with soft play equipment and safety flooring, this is a great addition for any event and will keep little ones entertained. We fully erect and set up the explorer for you. We also offer the explorer for birthday parties and celebrations.

### **General**

- (a) The contract is for the hire of equipment detailed on the contract. The parties to the contract are the Hirer, as an individual or an organisation whose official representative will be the signatory of the contract and Stags table & tent hire (part of the Stags Events group).
- (b) All equipment hired remains the property of Stags table & tent hire at all times.
- (c) Acceptance of goods and services from us implies that you have accepted our current Terms & Conditions.

### **Charges**

- (a) Hire charges will be for periods of 3 days (72 hours) or one week (7 days) or multiples, including Bank Holidays, as detailed on the hire contract.
- (b) Delivery and collection will be charged at current Stags table & tent hire rates. Failed delivery and collection attempts will be charged at £50 per journey.
- (c) All outstanding payments must be paid no later than 72 hours before the delivery date.

(d) Deposits will be requested as security on equipment hired and will be used against any outstanding payments. Any balance due is refunded back to the original source of the funds on return of equipment in sound/clean condition.

(e) For those customers who do not have a trading account with us, payment in full will be required to secure & confirm your order.

(f) Any parking fines or other parking costs incurred due to inadequate provisions made by the organisers of the event for delivery and collections by Stags table & tent hire will be re-charged to the Hirer.

(g) Any equipment unavailable for inspection or collection on the agreed date and time, will be deemed to be lost and a charge will be made to the Hirer equal to the current replacement value of the equipment. The Hirer agrees to pay for all equipment that is lost or damaged beyond repair. charges will continue until full payment is made.

(h) All cancellations must be confirmed in writing by the Hirer to Stags table & tent hire. In the event of a cancellation, the following charges will apply;

28 days or more prior to delivery – A minimum £25 cancellation fee will apply

Up to 27 days prior to delivery – 20% hire cost payable by Hirer

Up to 14 days prior to delivery – 35% hire cost payable by Hirer

Up to 7 days prior to delivery – 50% hire cost payable by Hirer

Up to 72 hours prior to delivery – Full charges will apply.

### **Responsibilities of The Hirer**

(a) Adequate delivery and collection access will be provided by the Hirer.

(b) The Hirer or his signatory will check quantities and condition of equipment on delivery and sign the contract to confirm agreement. Any damage or shortfall must be agreed, noted on the contract and signed off by both parties.

(c) The Hirer accepts full responsibility for the security and safe use of the equipment until collection or return to Stags table & tent hire.

(f) The Hirer must inform Stags table & tent hire as soon as practicable if an item on hire becomes faulty.

### **Responsibilities of Stags table & tent hire**

(a) Agreed hire rates will be maintained for the length of the contract.

(b) Appropriate instruction on the safe use and operation of the equipment will be provided by Stags table & tent hire. We do not accept responsibility for any loss or injury caused by the use of company equipment.

(c) Whilst Stags table & tent hire will make every endeavour to supply equipment as described, all items are offered subject to availability. Circumstances may lead to alternative products being supplied, but they will conform to the same standards.

(e) If equipment cannot be supplied on the agreed date because of circumstances beyond its reasonable control, Stags table & tent hire shall return all monies paid and not be liable to pay further compensation to the Hirer.

(f) The liability of Stags table & tent hire for any claims made by the hirer will not exceed the contract charge and does not extend to any consequential or financial loss caused by late or non-delivery, unsuitability, breakdown or lawful repossession.
